The Lesotho Highlands Development Authority (LHDA), Implementing Agency (IA) of the Lesotho Highlands Water Project, hereby invites suitably qualified Tenderers to submit Tenders for Construction Services for the construction of Polihali Dam and Appurtenant Works.

Trans-Caledon Tunnel Authority (TCTA) has applied for loans from different financial institutions, including the African Development Bank (AfDB) and New Development Bank (NDB) in various currencies towards the cost of the Lesotho Highlands Water Project – Phase II.

#### GENERAL SCOPE OF WORKS TO BE PROVIDED

Polihali Dam will be a 166 m high basalt Concrete Face Rockfill Dam (CFRD) situated on the Senqu (Orange) River near the town of Mokhotlong. The reservoir capacity will be 2 325 million cubic metres and apart from the main dam embankment, the project includes a 43 m high Saddle Dam (also CFRD); a 33 m high upstream cofferdam; 105 m high Intake Tower with a 5 m outlet tunnel/chute (to release 300 m<sup>3</sup>/s); a 98 m long ogee spillway designed to discharge 4 300 m<sup>3</sup>/s; two bridges, an Outlet House incorporating compensation and flood release valves as well as a 2 x 2.1 MW mini-hydropower station.

Specific details of the services required are provided in the Scope of Works (Section 6 of the RFT).

### **TENDER SUBMISSION**

Tenders must be submitted to the above office on or before **11:00 Hrs.** Lesotho time on **12 November 2021** and must be accompanied by a security of M 30,000,000.00 (Thirty Million Maloti).

LHDA is not bound to accept any of the Tenders submitted and may cancel the selection process at any time without providing any justification to prospective Tenderers.

Subject to COVID-19 restrictions, Tenders will either be opened in the presence of Tenderers' representatives who choose to attend at **12:00 Hrs.** Lesotho time on **12 November 2021** at the offices of the Lesotho Highlands Development Authority, LHWP2 Project Management Unit, **9<sup>th</sup> Floor Lesotho Bank Tower, Kingsway Road, Maseru, Lesotho**, or will be opened at a virtual meeting which will be accessible to all Tenderers' representatives, with access details to be provided at the appropriate time.
